- £1,000 Promotion/recruitment of YMOs (detailed plan already prepared)
- £1,000 Promotion/recruitment of female referees JR to provide detailed plan
- £1,350 MO videoing (10x £135/match)
- £2,350 any 'further' RFRU funding (beyond the £2.5k expected) to support remaining items listed in PFR-lite submission, including
- CMODs to be funded from 'BAU' spend
- General PR/marketing
