Safeguarding

As members are now required to complete a DBS check for youth rugby, it has required us to adapt. We have done some admirably.

Going forward, members are reminded of our guidance to take the formal 'RFU Play It Safe' module, with the costs covered by the Society.

I'm pleased to report no member has been subject to a Safeguarding complaint, however the issue of abuse is still with us.

The clubs and county are responding to the concern by issuing deterrent sanctions for transgression.
