3. Hosting of Sending-Off forms on WTR

 Recently WTR communicated that they can now 'host' RC forms, allowing for online submission by refs with (direct) transfer to 'home' CB Disciplinary Sec's. The potential pros & cons were discussed, and the following actions agreed: SB to contact Mark Brown (WTR) to confirm: Whether a 'review' mechanism exists/can be added (to allow Chris Parker (BRR's Disciplinary Officer) to 'QA' any forms before onward transmission)? Who would have visibility of 'published' reports? 	SB
4. Kit issue (rebranding/75 th season)	
It was agreed to progress an issue of kit to (i) reduce the 'surplus' held in the current account, (ii) commemorate the 75 th season of activity (BSRFUR having been founded in 1948), and (iii) help publicise the name-change from 'BSRFUR' to 'BRR' NC shared details of the RFU 'club hub' procurement platform, with clothing/kit options available, bearing the England Rugby rose (at v.low prices), to which the BRR logo could be added. It was subsequently agreed that members would be issued with a new t-shirt (colour TBC) and backpack.

5. Tackle Height DLV update	
Anecdotal evidence/feedback suggests most players & referees are adapting well to the revised tackle height; recognition given to need to focus on 'game mgmt' to maintain discipline, prevent unnecessary escalation of sanction, and ensure clarity/understanding of decisions taken – to be an ongoing focus area in monthly training sessions (NC to confirm with Crispin Davis)	NC
<u>6. Finances</u>	
KP confirmed HMRC are now asking for Corp.Tax returns (despite previous acceptance of 'non- commercial' nature of BRR and therefore no need for tax returns) KP, NC, PL to attend RFU-arranged webinar with tax expert on 7 th Sept – hopefully they will be able to provide suggestions/guidance on how to respond to HMRC Subsequent update: PL to take lead on correspondence with HMRC, given his past relationship with the RFU's Corp.Tax expert (through work)	KP,NC.PL
7. Fitness testing (& referee grading)	
 The previously issued guidance on fitness testing has been queried, so ExCom reviewed it, reaffirming that: The guidance, whilst no longer mandatory is still a useful marker for both BRR and individuals in maintaining/improving their fitness (and, as a consequence, their refereeing) No referee should be re-graded purely as a result of attaining/failing to attain a particular fitness target, though it may result in them not being prioritised for an appointment versus a ref that has done so
